**Affidavit Regarding a Foreign Academic Degree**

The Division for Evaluation of Foreign Academic Degrees evaluates foreign academic degrees in comparison to Israeli academic degrees, for the purpose of ranking and salary in the public sector.

This affidavit should be completed by a new immigrant/holder of a permit to work in Israel who has fled Ukraine during the 2022 Russia–Ukraine war due to danger who does not have the necessary documents in his/her possession and therefore is unable to present them to the Department for the purpose of supporting his/her application to evaluate the degree.

Certificate of the equivalence, if given on the basis of this affidavit, will be valid for one year from the day of issue, or until the obstacle to producing all the necessary documents is removed, whichever is the earlier, and subject to the Department's decision.

The affidavit has been prepared as Word file so that you can fill it in on the computer, turn it into a PDF file and upload it to the online system.

If you have in your possession documents that are evidence of your degree, upload them to the online system: diploma, academic transcript or other supporting documents [such as documents that show evidence of work experience].

A separate questionnaire should be completed for each academic degree.

Sign the affidavit at the end of the questionnaire and have it signed by a lawyer.
